

HANNAFORD SAVOR THE FLAVORS OF SUMMER SWEEPSTAKES PHASE 2
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT’S CHANCES OF WINNING.

The Hannaford Savor the Flavors of Summer Sweepstakes Phase 2 (“Sweepstakes”) is sponsored by Hannaford Bros. Co., LLC, (“Sponsor”), 145 Pleasant Hill Road, Scarborough, ME 04074, and is administered by Prize Logic, LLC, (“Administrator”), 25200 Telegraph Road, Suite 405, Southfield, MI 48033. Sweepstakes includes a coupon offer, as described in Section 3 below.

1. SWEEPSTAKES PERIOD: The Sweepstakes begins on June 25, 2017 at 12:00 PM Eastern Time (“ET”) and ends on August 12, 2017 at 11:59:59 PM ET (“Sweepstakes Period”). The Sweepstakes consists of a grand prize drawing (“Grand Prize Drawing”) that runs the entire length of the Sweepstakes Period and six (6) weekly entry periods (each a “Weekly Entry Period”) as outlined in the chart below:

Non-winning entries will carry over into subsequent Weekly Entry Period drawings. The Administrator’s computer is the Sweepstakes official clock.

2. ELIGIBILITY: This Sweepstakes is open only to legal residents of Maine, Massachusetts, New Hampshire, New York, and Vermont, who are at least eighteen (18) years old at the time of entry. Employees of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, “Sweepstakes Entities”) and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the “steps” of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited or restricted by law.

Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an entrant’s residential address and e-mail address

will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address.

3. HOW TO ENTER THE SWEEPSTAKES AND RECEIVE AN OFFER: There are two (2) ways to enter the Sweepstakes:

A. Make a Purchase: During the Sweepstakes Period, an eligible entrant may purchase at least \$5 of participating products from a Hannaford store (see Appendix for list of participating products). Upon completion of the transaction, an entrant will automatically receive one (1) code (“Code”) printed on his/her register receipt. An entrant may then visit www.hannaford.com/flavorssofsummer (“Website”) and complete and submit the registration form including, but not limited to: his/her first and complete last name (no initials), valid e-mail address, phone number, street address (no P.O. Boxes will be allowed), city, state, zip code, and the Code from his/her receipt. Upon the successful submission of the registration information, an entrant will receive one (1) entry into the applicable Weekly Entry Period and one (1) entry into the Grand Prize Drawing.

B. Free Method: During the Sweepstakes Period, an eligible entrant may hand-write his/her complete name (no initials), valid e-mail address, street address (P.O. Boxes not accepted), city, state, ZIP code, telephone number, and date of birth (MM/DD/YYYY) on a 3½”x5” card (“Mail-In Entry”) and mail it with sufficient postage to: the Hannaford Savor the Flavors of Summer Sweepstakes, P.O. Box 251328, West Bloomfield, MI USA 48325. All Mail-In Requests must be postmarked by and received by the dates indicated in the chart above in Section 1, in order to be eligible. Entrant will receive one (1) entry into the applicable Weekly Entry Period and one (1) entry into the Grand Prize Drawing.

Mail-In Entries must be legibly hand-written. Mechanical reproductions, postage-due, Mail-In Entries mailed in an envelope or sent in excess of the entry limits set forth below will not be accepted. Mail-In Entries received without a verifiable and legible return address will be deemed incomplete and not valid entries.

Entry Limit: Regardless of the method of entry, there is a limit of one (1) entry per person per day during the entire Sweepstakes Period. If more than one (1) entry per day is received from the same person, and/or e-mail address in a single day, only the first entry received may be considered valid. A “day” is defined as starting at 12:00 AM (midnight) ET and ending at 11:59:59 PM ET on a calendar day during the Sweepstakes Period, except on June 25, 2017 when a day is defined as starting at 12:00 PM ET and ending at 11:59:59 PM ET.

Coupon Offer: When an eligible entrant purchases at least \$5 of participating products during the Sweepstakes Period, as described in Section 3A above, he/she will receive a coupon with his/her receipt valid for a discount on his/her next shopping order. The value for the discount will depend on the amount spent on participating products:

All participating products must be purchased in a single transaction. Limit one coupon per transaction. Coupon terms: Coupons are subject to any terms and conditions set forth by the issuer and/or printed thereon. Order must meet minimum purchase requirement (i.e., coupon discount value) after all

discounts are applied. Valid only at Hannaford Supermarkets. No cash value. Limit one coupon per household. Not valid toward purchase of gift cards, money orders, alcoholic beverages, tobacco products, prescriptions, lottery tickets, services and items prohibited by law. Void if altered, copied or sold, exchanged, posted or obtained on the internet.

4. RANDOM DRAWINGS: On or around each of the drawing dates indicated in the chart above in Section 1, the Administrator will randomly select one (1) potential Weekly Entry Period winner (each a “Weekly Entry Period Winner”) from all eligible entries received during the respective Weekly Entry Period. There will be total of six (6) Weekly Entry Period prizes (one [1] per Weekly Entry Period). On or around August 23, 2017, Administrator will randomly select one (1) potential grand prize winner (“Grand Prize Winner”) from all eligible entries received during the Sweepstakes Period. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

5. PRIZES, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:

A. Grand Prize (1): The grand prize is groceries for one (1) year awarded as fifty two (52) \$100 Hannaford gift cards (one [1] awarded per calendar week) and a check for \$300 (“Grand Prize”). One (1) Grand Prize will be awarded during the Sweepstakes. The ARV of the Grand Prize is \$5,500.

B. Weekly Entry Period Prizes (6 [1 per Weekly Entry Period]): Each Weekly Entry Period winner will receive a \$500 Hannaford Grocery gift card (“Weekly Entry Period Prize”). Six (6) Weekly Entry Period Prizes (one [1] per Weekly Entry Period) will be awarded during the Sweepstakes. The ARV of each Weekly Entry Period Prize is \$500.

C. ARV: The total ARV of all prizes in the Sweepstakes is \$8,500.

D. Odds of Winning: The odds of winning the Grand Prize depend on the number of eligible Sweepstakes entries received during the Sweepstakes Period and the odds of winning a Weekly Entry Period Prize depends on the number of eligible Sweepstakes entries received during each respective Weekly Entry Period.

E. General Conditions: Terms and conditions of gift cards apply. In no event will more prizes than are stated in these Official Rules be awarded. If, for any reason, more prize notifications are sent (or more claims are received) than the number of prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of prizes through a random drawing from among all eligible prize claims received. There is a limit of one (1) Grand Prize and one (1) Weekly Entry Period Prize per person/household. Terms and conditions of gift cards apply.

6. HOW TO CLAIM A PRIZE: After the random drawings, Administrator will notify each potential winner via e-mail at the e-mail address provided at the time of registration. Before being declared the winner the potential Grand Prize Winner will be required to sign and execute an Affidavit of Eligibility/Liability & Publicity Release and tax acknowledgment (“Affidavit”). The potential Grand Prize Winner must return a fully executed and notarized Affidavit to the Sponsor or its authorized designee within ten (10) calendar days from the date it is postmarked as being sent to the potential Grand Prize Winner or the Grand Prize may (in Sponsor’s sole discretion) be forfeited. If a potential winner is disqualified, found to be ineligible or not in compliance with these Official Rules, declines to accept a prize, or in the event that the potential Grand Prize Winner fails to return an executed and notarized Affidavit within the ten (10) calendar day deadline, the respective prize may be forfeited. If a prize is forfeited,

the prize may be awarded to an alternate winner, selected in a random drawing from among all remaining eligible entries, as determined by Sponsor in its sole discretion. If, after a good-faith attempt, Sponsor is unable to award or deliver a prize, the prize may not be re-awarded.

Sponsor will attempt to notify each potential winner as set forth above, but Sponsor is not responsible for any undelivered e-mails, including without limitation e-mails that are not received because of a winner's privacy or spam filter settings which may divert any Promotion e-mail, including any winner notification e-mail, to a spam or junk folder. Prizes that are unclaimed, unredeemed, or returned as undeliverable will not be awarded. Prizes are non-transferable and no prize substitution, exchange or cash equivalent will be allowed, except by Sponsor, who reserves the right to substitute a prize of equal or greater value in case of unavailability of the prize or force majeure, at Sponsor's sole and absolute discretion. Sweepstakes Entities shall not be held responsible for any delays in awarding the prize for any reason.

LIMITATION OF LIABILITY:** By participating in this Sweepstakes, entrants agree that the Sweepstakes Entities and each of their respective affiliates, subsidiaries, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers and each their respective officers, directors, stockholders, employees, representatives, designees and agents ("Released Parties") are not responsible for: (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail/text notifications or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/network accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Sweepstakes; (vii) any injury or damage, whether personal or property, to entrants or to any person's computer related to or resulting from participating in the Sweepstakes and/or accepting a prize; and (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. Further, the Sweepstakes Entities are not responsible for any unanswered or undeliverable winner notifications.

If, for any reason, the Sweepstakes is not capable of running as planned, Sponsor reserves the right, at its sole and absolute discretion, to cancel, terminate, modify or suspend the Sweepstakes and/or proceed with the Sweepstakes, including the selection of a winner in a manner it deems fair and reasonable, including the selection of a winner from among eligible entries received prior to such cancellation, termination, modification or suspension. In no event will more prizes be awarded than are stated in these Official Rules. In the event that, due to technical, typographical, mechanical, administrative, printing, production, computer or other errors, there are more winners than are stated in these Official Rules, a random drawing among the claimants will be held to determine the winner.

DISPUTES: THIS SWEEPSTAKES IS GOVERNED BY, AND WILL BE CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF MICHIGAN, AND THE FORUM AND VENUE FOR ANY DISPUTE SHALL BE IN THE OAKLAND COUNTY, MICHIGAN. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY THE AMERICAN ARBITRATION ASSOCIATION IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("AAA RULES"). THE AAA RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
